

LIMITED 2 YEAR WARRANTY

VentorLux warrants, for a period of twenty four (24) months from the date of acquisition that all products, component parts, and accessories, will be free from defects in material and workmanship under normal use and service.

THE Customers SOLE AND EXCLUSIVE REMEDY UNDER THIS WARRANTY IS LIMITED TO THE REPAIR OR REPLACEMENT OF DEFECTIVE PARTS. ALL DEVICES SHOULD BE RETURNED TO VENTORLUX FOR REPAIR OR REPLACEMENT.

To keep this warranty in effect for the aforementioned TWENTY FOUR month period, the Customer must (i) promptly, i.e., immediately upon discovery, inform VentorLux customer service of any defects, and (ii) properly use the Product in accordance with guidelines outlined in the manual, and (iii) refrain from any tampering with the product.

This warranty does not cover normal wear and tear, or defects caused by (i) improper or negligent handling or unauthorized modifications; (ii) defective or improper premises, chemical, or electrical influences; or (iii) weather or other forces of nature.

To provide the best customer service possible, VentorLux requires the Customer to complete the LIMITED WARRANTY REGISTRATION FORM and submit to VentorLux within 30 days of acquisition date.
